The statement he made in his third question regarding "it appears the students money may be locked up with the government" is NOT a valid statement.. in fact, it makes NO sense... I answered as best as I could without calling him out on it LOL

Also, I am waiting for [REDACTED] to answer the last question because our program hours are the same as FBCs because the hours are mandated by the state of NC. They have to have a mandated number of hours for licensure, we abide by that as does FBC... I answered based on that, but I think being able to add a number would be even better.

Will all of the credits from Fayetteville Beauty College transfer? If not, how many. We are treating the work they completed at FBC as "Credit for Prior Learning" which is something Fayetteville Technical Community College is known for across the nation. Fayetteville Beauty College operates on a clock-hour format and while we abide by the clock hour requirements for NC licensure, we use a semester-hour format. We will review each student's completed hours at Fayetteville Beauty College and award semester hour credit as it is equivalent in content and contact hours. Our goal is for the Fayetteville Beauty College students to keep all of the hours they have already earned.

-How many students have enrolled with you all? We recently visited FBC and 23 students completed applications to start at FTCC.

How will financial aid, student loans and tuition work since it appears the students money may be locked up with the government? Each student's financial aid is different. Our Financial Aid department will look at every FBC student who applies to come here and do everything we can to make their transition to FTCC as seamless as possible. If there are any issues, we have an excellent payment plan which is available to all of our students and certainly helps out with funding. Also, we are not requiring them to purchase any additional equipment, and that will save them money as well.

-How many hours for certification through your program? The hours required for NC licensure are the same at FTCC as they are for FBC. The only difference is that here, students can earn an Associate's Degree.
